Bruxelles, 27 October 2016 - Last October 25<sup>th</sup> Taner Aykac has been appointed Managing Director

(CEO) of CCB by the Board of Directors of the Belgian company. The Board of Directors has also

appointed Eddy Fostier as General Manager of CCB.

53 years old, Belgian, an MBA, and a Bachelor of Science in Engineering, Aykac holds a top level

managerial experience acquired in large multinational groups. He started his career in the agrochemical

sector for Pioneer Overseas Corporation/ DuPont in 1988, and subsequently for chemical and

pharmaceutical multinationals such as Ciba-Geigy, Novartis and Zeneca, where he has been successfully

in various senior roles till 2000, including M&A and business integration.

From 2000 to 2011 he covered growing responsibility roles in Syngenta Group, heading the EMEA area of

the multinational agribusiness company.

In 2011, Aykac has been appointed CEO of Cimentas - a Cementir Group subsidiary in the Turkish cement

and ready-mixed concrete business contributing to the reorganization of the company. He worked in Turkey

until the end of 2015, once he was asked to follow relevant business integration processes for Cementir

Holding in Rome, that led to the acquisition of Sacci (a leading Italian cement company) and CCB.

of Cementir Holding, stated: "Taner Aykac will guarantee a smooth and full successful integration of the
